This Permit Assignment form is designed to allow a permitee to transfer the responsibilities of an existing Rice Creek Watershed District (RCWD) permit for all or a portion of a site to another party without reapplying for permit coverage. (Example: developer sells lots to builder, each builder completes this form.) A new escrow agreement and replacement surety must accompany the permit assignment request, when applicable. Significant changes to the existing permit will not be allowed with this form; a new permit application or amendment request must be submitted in such a case.

DO NOT SELL OR OTHERWISE TRANSFER ANY PART OF AN INCOMPLETE PROJECT BEFORE COMPLETING THIS FORM! Until assignment is approved, the permit holder as well as the current title owner will be responsible for the permit requirements (bare soil stabilization, silt fence removal, etc.) EVEN IF lots are sold and under the control of other parties. Make this form a requirement for completing the sale!
